### Use of cookies through the website [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup>

#### The website [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup> uses cookies.

Cookies are files sent to a browser through a web server to record the activities of the User on this website (hereinafter, the Services). The first purpose of cookies is to provide the User with quicker access to the selected Services. In addition, cookies personalise the services offered by the website [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup>, offering and providing each user with information that is of interest or that may be of interest to them, in accordance with their use of the Services.

The website [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup> uses cookies to personalise and facilitate the user's browsing as much as possible. The cookies are only associated with an anonymous User and their computer and do not provide references that allow us to deduce the User's personal details. The User may configure their browser to notify and reject the installation of Cookies sent by the website [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup>, without it being detrimental to the User's ability to access the Contents. However, we would like to point out that, in any case, the quality of the functioning of the website may decrease.

Users who register or who have logged in may benefit from more personalised services oriented to their profile, thanks to the combination of the data stored in the cookies and the personal data used at the time of their registration. These Users expressly authorise the use of this information for the stated purpose, without prejudice to their right to refuse or disable the use of cookies.

Likewise, the website [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup> will be able to know all the Services requested by the Users, so that they can provide or offer information that is appropriate to the tastes and preferences of each User.

### Type, purpose and functioning of cookies:

Cookies, depending on their permanence, can be divided into session or permanent Cookies. The former expire when the User closes the browser. The latter expire when the purpose for which they are used is fulfilled (for example, so the User continues to be identified in the Services of [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup>) or when they are manually deleted.

Additionally, in accordance with their purpose, cookies can be classified as follows:

- **Log cookies:** Log Cookies are generated when the User has registered or after having opened their session, and they are used to identify them in the Services with the following objectives:

To keep the User identified so that if a Service, the browser or the computer close and at another time or on another day they re-enter the Service, they will continue to be identified, thus facilitating their browsing without having to identify themselves again. This functionality can be deleted if the User clicks the 'close session' functionality, so that this Cookie will be deleted and the next time they enter the Service the User will have to log in to be identified.

Additionally, some Services may use connectors with social media such as Facebook or Twitter. When the User registers in a Service with social media credentials, they authorise the social media to keep a persistent Cookie that remembers their identity and guarantees them access to the Services until it expires. The User can delete this Cookie and revoke access to the Services through social media by updating their preferences in the social media that they specify.

- **Analytics cookies:** Each time a User visits a Service, a tool from an external provider generates an analytics Cookie on the User's computer. In future visits, this Cookie, which is only generated during the visit, will serve the Services of [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup> to identify the visitor anonymously. The main objectives that are pursued are:

- To allow the anonymous identification of browsing Users through the 'Cookie' (it identifies browsers and devices, not people) and therefore the approximate count of the number of visitors and their trend over time.

- To anonymously identify the most visited contents and therefore those which are most attractive to Users and know if the User who is accessing them is new or returning.

Important: Unless the User decides to register in a Service of [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup>, the 'Cookie' will never be associated with any personal details that can identify them. These Cookies will only be used for statistical purposes that help optimise the experience of the Users on the site.

- **Advertising Cookies:** These types of 'Cookies' allow the information of the adverts shown to each anonymous User in the [comunitatvalenciana.com](http://comunitatvalenciana.com) <sup>[1]</sup> Services to be expanded. Among others, the duration or frequency of displaying advertising positions, the interaction with them, or the browsing and/or behavioural patterns of the User are stored, as they help to shape a profile of advertising interest. In this way, they allow advertising that is related to the interests of the User to be displayed.

**How to disable Cookies in the main browsers:**

It is usually possible to stop accepting browser Cookies, or stop accepting cookies from a particular service.

All modern browsers allow you to change the Cookies settings. These settings are usually found in the ?options? or ?Preferences? menu of your browser.

### **Updates and changes to the privacy policy and cookies**

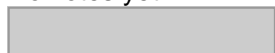
